**REPEAL AND REPLACE RESOLUTION 2009-10
WATER ALLOTMENT TRANSFER REQUESTS GRANTED
IRRIGATION ASSESSMENT ADDED**

WHEREAS, the Board of Directors of the Kennewick Irrigation District (District) met in open public session on July 6, 2010 with a quorum present, and

WHEREAS, the legal owners of the parcels identified on Amended Attachment "A" hereto, located within the boundaries of the District, have requested that their parcel receive a transfer of water allotment; and

WHEREAS, the legal owners of the parcels identified on Amended Attachment "A" hereto have agreed to be bound by all obligations applicable to lands which receive water from the Kennewick Irrigation District, including but not limited to the obligation to pay assessments as established by the Kennewick Irrigation District Board of Directors; and

WHEREAS, the District has persons within its boundaries wishing to transfer their water allotments; and


WHEREAS, the District has confirmed with the USBR that the permanent transfer of the water allotment to the parcels described on Amended Attachment "A" hereto is permissible and is approved under the District/USBR contract; and

WHEREAS, the USBR has confirmed the total irrigable acreage and water allotment for the District will not be changed by the transfer of said allotment to other properties within the District Boundary; and,


WHEREAS, the requirements of the Kennewick Irrigation District for water allotment transfer have been deemed satisfied and all monies and/or obligations to the District due and owing have been paid in full;

NOW, THEREFORE, BE IT RESOLVED water allotment to parcels described herein be established and an irrigation assessment for the allotment to the parcels described in Amended Attachment "A" hereto which is hereby incorporated herein as though fully set forth, was added to the Kennewick Irrigation District's assessment rolls effective January 1, 2009, that said parcels are hereafter bound by all obligations applicable to lands which receive water within the Kennewick Irrigation District, including but not limited to the obligations to pay assessments as established by the Kennewick Irrigation District Board of Directors. On July 6, 2010, the Kennewick Irrigation District Board of Directors removed 19.86 acres of irrigation assessment in Parcel Number 1-2188-200-0003-000 that is outside of the District Boundary.

Resolution No. 2010-13 to Repeal and Replace Resolution 2009-10 is hereby adopted by the Board of Directors of Kennewick Irrigation District, Benton County, Washington, at an open public meeting thereof this 6th day of March, 2010.
