

WHEREAS, the Yakima Federal Savings & Loan Association requires the Kennewick Irrigation District to supply an endorsement for the undersigned on any check or other instrument tendered for an account held at the Yakima Federal Savings & Loan Association and to relieve the Yakima Federal Savings & Loan Association of any liability in connection with collections of such items which are handled by the Yakima Federal Savings & Loan Association without negligence and to not hold the Yakima Federal Savings & Loan Association liable for the acts of its agents, sub-agents or others or for any casualty.


NOW, THEREFORE, BE IT RESOLVED, the Kennewick Irrigation District shall supply an endorsement for the undersigned on any check or other instrument tendered for an account held at the Yakima Federal Savings & Loan Association and relieves the Yakima Federal Savings & Loan Association of any liability in connection with collections of such items which are handled by the Yakima Federal Savings & Loan Association without negligence and shall not hold the Yakima Federal Savings & Loan Association liable for the acts of its agents, sub-agents or others or for any casualty; and any of the persons named below shall be authorized to sign and/or co-sign for banking and investment services for the Kennewick Irrigation District at the Yakima Federal Savings & Loan Association:
