This work is planned to be completed before the 2025 irrigation season.

Yes, other projects which will require material are planned in the District.

A previous SEPA has been completed for the adjacent KID canal lining project, this SEPA and the related MDNS are KID file number TD 2020-04. A SEPA review was also completed for Main Canal Lining 11.0 and 12.0 Siphon Removal, MDNS KID file number TD 2023-03. In addition, an Archaeological Survey Report was completed for the Kennewick Irrigation District Title Transfer Project. The report found no cultural resources identified within the Main Canal Division II Canal Right-of-Way in which this project is located.

No known applications for governmental approval are pending for this proposal.

The grading project is planned to occur in the vicinity of the Main Canal Milepost 10.4 and consists of the removal of approximately 15,000 cubic yards of material from within the canal right of way to be used in other areas of the canal construction and KID projects in Badger Canyon where necessary.

The project is located along a section of the Main Canal Division II within the Benton County, Washington, and will begin approximately 2,200 feet to the east of where the canal is crossed by Webber Canyon Rd. The project is located in Sections 33 and 34, of Township 9 North, Range 27 East, Willamette Meridian. A map has been included to show the location of the proposed project (Appendix A).

The project site is generally sloped with a maximum existing slope of 80% grade.

c. What general types of soils are found on the site (for example, clay, sand, gravel, peat, muck)? If you know the classification of agricultural soils, specify them, and note any agricultural land of long-term commercial significance and whether the proposal results in removing any of these soils.

According to the US Department of Agriculture, Natural Resources Conservation Service the soil in the site are classified as Warden Silt Loam (WdAB, WdE3), and Finley stony fine sandy loam (FfE).

d. Are there surface indications or history of unstable soils in the immediate vicinity? If so, describe.

None known.

e. Describe the purpose, type, total area, and approximate quantities and total affected area of any filling, excavation, and grading proposed. Indicate source of fill.

The design for this project is not currently complete. The project will remove material from within the canal right-of-way for use in other locations such as the 2018 WaterSMART Grant (refer to MDNS TD 2020-04) as well as future KID projects in Badger Canyon. The hillside will be graded to stabilize slopes and will remove the existing 80% slopes. The project area is approximately 1 acre and will generate approximately 15,000 cubic yards of material.

#### f. Could erosion occur because of clearing, construction, or use? If so, generally describe.

Yes. Grading of the site could result in minor occurrences of rill erosion on bare dirt surfaces during construction if precipitation occurs. In addition, wind erosion can occur during construction, but will be kept to a minimum through the use of erosion control best management practices.

# g. About what percent of the site will be covered with impervious surfaces after project construction (for example, asphalt or buildings)?

No impervious surfaces will be constructed at the site.

#### h. Proposed measures to reduce or control erosion, or other impacts to the earth, if any.

Appropriate best management practices will be employed to reduce erosion at the project site, as warranted.

Fugitive dust would be expected to be present as a result of the grading activities that will occur as part of the proposed project. Diesel emissions would result from construction machinery.

Appropriate best management practices will be employed to reduce and control emissions into the air at the project site, as warranted.

There are no surface water bodies in the immediate vicinity of the site, beyond man-made irrigation canal. The canal will eventually drain into the Columbia River.

The grading work will not occur within 200 feet of the canal (see Appendix A).

Very minor amounts of sediments and fuel/lubricants from heavy machinery could discharge into the dewatered canal or over the MC 10.4 siphon. Sediments and wastes in the canal could be transported by irrigation water once irrigation season commences in spring. Best Management Practices will be used to contain all waste materials.

Any potential water runoff (including stormwater) at the site will likely flow across the site and be impounded against the canal embankment or flow over the MC 10.4 Siphon. Water flowing over the MC 10.4 Siphon will enter a drainage channel that ends at the edge of a cultivated field where it would become overland flow and infiltrate into the soil. If water enters the canal, during the part of the season when the canal is dry, this water will likely remain in the canal until it evaporates. Remaining water will mix with irrigation water during the irrigation season and be consumed by irrigation customers.

### b) Could waste materials enter ground or surface waters? If so, generally describe.

Minor waste materials could possibly enter ground waters as water infiltrates into the subsurface. Waste materials entering the canal will be collected at the end of the project, preventing entrance to surface waters.

# c) Does the proposal alter or otherwise affect drainage patterns in the vicinity of the site? If so, describe.

The drainage patterns will remain unaltered.

# Proposed measures to reduce or control surface, ground, and runoff water, and drainage pattern impacts, if any.

As needed, best management practices will be used to reduce sedimentation and waste spills into the canal and crossing over the MC 10.4 Siphon during project construction. Runoff, including stormwater, will be accepted into the canal.

Work would occur during normal daytime working hours weekdays and occasional Saturdays, eliminating noise at night that may disturb area residents.


