A **RESOLUTION** of the Board of Directors of Kennewick Irrigation District (KID), Benton County, Washington, for the purpose of accepting project completion on a public works project.

Section 1. RECITALS AND FINDS.

1.1 KID enters into various public works contracts for the purpose of completing the necessary installation and repair of various irrigation infrastructure.

1.2 Contract PW2024-01 PSA 188 Pump Modification and Evaluation was entered into with Layne of Washington, Inc. on March 27, 2024.

Section 2. PROJECT ACCEPTANCE AND RETAINAGE RELEASE.

of Revenue, Washington Department of Labor and Industries and the Washington State Employment Security Department.


Section 3. IMPLEMENTATION. The KID District Manager is hereby authorized and directed to take such action as appropriate and necessary to administer and enforce this Resolution.




