KENNEWICK IRRIGATION DISTRICT RESOLUTION 2024-53

Authorization to Waive Competitive Bidding and Award a Contract to Purchase a Vortex TR Granular Blower from Vortex Granular Systems, LLC Pursuant to RCW 87.03.435(3)(c)

A **RESOLUTION** of the Board of Directors of Kennewick Irrigation District (KID), Benton County, Washington, for the purpose of accepting project completion on a public works project.

Section 1. RECITALS AND FINDINGS

1.1 The Board of Directors of Kennewick Irrigation District (KID) has established a General Purchasing Policy 2.13 that outlines the rules for acquiring services, contractors, materials, supplies, and equipment.

1.2 1.2 RCW 87.03.435(3)(c) allows for establishing the purchase price by direct negotiation if the purchase is clearly limited to a single source of supply or involves special facilities, services, or market conditions.

Section 2. PURCHASE OF A VORTEX TR GRANULAR BLOWER

2.1 The KID has a Stihl backpack that is in need of replacement.

2.2 The new Vortex Granular Systems blower equipment totals \$4,410.00, plus applicable fees and sales taxes.


2.3 Replacing the equipment will improve efficiency. KID Staff has determined through a vendor search that Vortex Granular Systems LLC is the sole source manufacturer and replacement parts supplier for blowers of this nature.

2.4 The Kennewick Irrigation District waives competitive bidding and authorizes the award of a sole source contract to purchase Vortex TR Aquatic Granular Blower for an amount not to exceed \$4,410 plus tax and applicable fees. The District Manager is authorized to execute contracts with Vortex Granular Systems, LLC, Inc. for the purchase of Vortex TR Aquatic Granular Blower.


Section 3. IMPLEMENTATION. The KID District Manager is hereby authorized and directed to take such action as appropriate and necessary to administer and enforce this Resolution.


