KENNEWICK IRRIGATION DISTRICT RESOLUTION 2025-13

Authorizing Collection for Properties to be Provided Service in 2025; Amending Resolution 2025-12

A **RESOLUTION** of the Board of Directors of Kennewick Irrigation District (KID), Benton County, Washington, relating to certain rates and charges; applying District Resolution 2025-01, establishing certain rates and charges for related properties subdivided in 2024 to be provided service in 2025; and, authorizing and directing actions; and Amending Resolution 2025-12.

Section 1. RECITALS AND FINDINGS.

1.1 On March 18, 2025, the KID Board approved Resolution 2025-12 Application of Resolution 2025-01; Authorizing Collection for Properties to be Provided Service in 2025. Resolution 2025-12 exercised the District's authority under RCW 87.03.445(5) to provide appropriate rates and charges for newly created lots within the District. Resolution 2025-13 amends this Resolution to 1) include additional properties and correct assessment amount errors, and 2) allow for a 60-day waiver of penalties and interest to affected properties.

1.2 This Resolution amends Resolution 2025-12, which set forth KID's program for rates and charges (including charges in lieu of assessments) for properties that were subdivided in 2024 but were not identified as separate tax parcels until 2025, including additional properties that were inadvertently not included in Exhibit A of Resolution 2025-12. Such properties will be served by the District in 2025 and are subject to the District's rates and charges. In addition, several assessment errors were discovered and have been corrected. The Revised List is attached as Exhibit A to this Resolution.

1.3 This Resolution also waives all penalties and interest for the properties on the Revised List attached as Exhibit A to this Resolution, for all assessments due on April 30, 2025, until June 30, 2025; essentially allowing an additional 60 days for the payment of the first half of 2025 assessments to these properties.

Section 2. AFFECTED PROPERTIES. This resolution amends Resolution 2025-12 to include the Revised List of properties attached as Exhibit A, attached and incorporated into this Resolution.

Section 3. RESOLUTION 2025-01 APPLIES; PENALTIES AND INTEREST WAIVED.

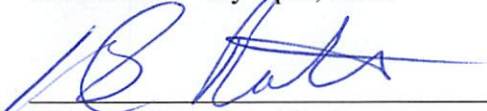
All properties identified in Exhibit A herein shall be and are subject to all applicable rates, charges and any assessments for collection in 2025 under District Resolution 2025-01 (January 7, 2025) upon the effective date of this Resolution. All penalties and interest for any payment not received by the properties on Exhibit A by April 30, 2025, shall be waived until June 30, 2025.

Section 4. IMPLEMENTATION. The KID District Manager is hereby authorized and directed to take such action as appropriate and necessary to administer and enforce this Resolution.

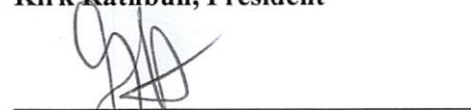
Section 5. REPEALER; FUTURE ACTIONS. Any KID act prior to and inconsistent with this Resolution is hereby superseded and repealed. Nothing in this Resolution shall limit the future authority of KID to modify, rates charges and assessments.

Section 6. EFFECTIVE DATE. This Resolution shall take effect and be in force upon final adoption by the Board.

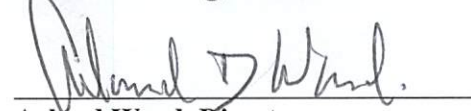
