- 1. How would the proposal be likely to increase discharge to water; emissions to air; production, storage, or release of toxic or hazardous substances; or production of noise?**

The proposal is not likely to increase discharge to water; emissions to air; production, storage, or release of toxic or hazardous substances; or production of noise.

The adoption of the West Richland Master Plan will provide guidance for replacement of existing irrigation systems and installation of new irrigation systems as development occurs.

- **Proposed measures to avoid or reduce such increases are:**

The West Richland Master Plan may reduce noise through the consolidation of pump stations.

- 2. How would the proposal be likely to affect plants, animals, fish, or marine life?**

The completion of the master plan will eliminate several existing pond facilities. Vegetation can be found in unlined pond facilities.

- **Proposed measures to protect or conserve plants, animals, fish, or marine life are:**

None proposed. The ponds are an irrigation facility and riparian vegetation is not naturally occurring in this location.

- 3. How would the proposal be likely to deplete energy or natural resources?**

None proposed.

- **Proposed measures to protect or conserve energy and natural resources are:**

The West Richland Master Plan will reduce the total number of existing and future pump stations that pressurize irrigation water within the master plan extents. These existing and future irrigation systems will be consolidated into three regional facilities which will operate during the irrigation season. It is expected that this pump consolidation action will conserve energy.

No impacts are anticipated to environmentally sensitive areas as a result of this proposal. The Badger East Lateral has been determined eligible for listing according to the Washington Information System for Architectural & Archaeological Records Data. The proposed master plan will not impact the canal other than to reduce water deliveries.

- **Proposed measures to protect such resources or to avoid or reduce impacts are:**  
None proposed.

- 5. How would the proposal be likely to affect land and shoreline use, including whether it would allow or encourage land or shoreline uses incompatible with existing plans?**

The proposed master plan will not affect land and shoreline use or encourage shoreline uses incompatible with existing plans.

- **Proposed measures to avoid or reduce shoreline and land use impacts are:**  
None proposed.

- 6. How would the proposal be likely to increase demands on transportation or public services and utilities?**

The proposal will not increase demands on transportation or public services.

- **Proposed measures to reduce or respond to such demand(s) are:**  
Electricity use should decrease through the consolidation of pump stations.

- 7. Identify, if possible, whether the proposal may conflict with local, state, or federal laws or requirements for the protection of the environment.**

The proposal will not conflict with local, state, or federal laws or requirements for the protection of the environment.





Figure 1: West Richland Master Plan
